Financial Responsibility Statement 2021

I acknowledge that by registering for classes this academic year, which consist of Fall, Spring and Summer semesters, at the University of Mary Washington (UMW), tuition and fees will be assessed to my student account. I understand and agree that if I drop or withdraw from some or all of the classes for which I register, I will be responsible for paying all or a portion of tuition and fees in accordance with UMW's published tuition refund schedule. I further understand that my failure to attend class or receive a bill does not absolve me of my financial responsibility as described above.

I understand if I fail to pay any unpaid balance on my student account I will be personally responsible for and agree to pay all costs and fees of collection. I understand and agree that the following delinquent account policies shall apply if I fail to pay any monies due and owing UMW by the schedule due date:

Returned Transaction Fees: UMW will impose a handling fee for any returned checks or dishonored credit card or debit card payments.

Financial Hold: UMW will place a financial hold on my student account, preventing me from registering for future classes, requesting transcripts, or receiving my diploma.

Late Payment Charge: UMW will assess late payment charges of not more than 10% of the past due amount.

Interest Charges: UMW will assess interest on the unpaid balance at the annual rate of 6% unless an alternative rate has been prescribed by state or federal law or regulation.

Collection Agency Fees: UMW may refer my delinquent account to an attorney or a collection agency. If the matter is referred for collection to an attorney or to a collection agency, then I will be liable for reasonable attorney's fees or additional collection fees of the then unpaid balance. UMW may also report my delinquent account to one or more of the national credit bureaus and to the Virginia Department of Taxation pursuant to the Setoff Debt Collection Act, Va. Code §58.1-521 et seq.

I authorize the University of Mary Washington and its respective agents and contractors to contact me regarding my student account or student loan at any future number that I provide for my cellular phone or other wireless device and I agree that such communications may use automated telephone dialing equipment or artificial or pre-recorded voice or text message.
